1. Bardibas Municipality Office has received Funds from the Government of Nepal (GoN) and AEPC towards the cost of **Supply, Delivery and Installation of Solar Street Light** and intends to apply part of the funds to cover eligible payments under the Contract. Bidding is open to all eligible and qualified Bidders/Suppliers.
2. The Bardibas Municipality Office invites sealed bids or electronic bids from registered eligible and qualified Suppliers/Bidders under National Competitive Bidding (NCB) for the **Supply, Delivery and Installation of Solar Street Light** as per the required specifications mentioned.
3. Interested Eligible Bidders may obtain further information and inspect the Bidding Document in English at the office of Bardibas Municipality as mentioned above.
4. Complete set of Bidding Document in English may be purchased from the office of Bardibas Municipality, Bardibas, Mahottari Nepal during office hours on all working days by eligible bidders 2073/11/18 onwards on the submission of a **Written Application**, copies of **Firm/Institution Registration** and **PAN/VAT Registration** certificates and upon payment of a non-refundable fee as mentioned above. The Bid document shall be available for sale up to office hours till 2073/12/17. If so requested, the Bidding Document can also be sent by post/courier services. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.
5. Pre-bid meeting shall be held at Bardibas Municipality Office, Bardibas, Mahottari at 2:00 pm on 2073/12/04.
6. Sealed or electronic bids must be submitted to the office of Bardibas Municipality, Bardibas, Mahottari, Nepal by hand/courier or through PPMO website www.bolpatra.gov.np on or before **12:00 pm on 2073/12/18**. Bids received after this deadline will not be accepted.
7. Received Sealed Bids shall be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 2073/12/18**, at the office of Bardibas Municipality, Bardibas, Mahottari, Nepal. But nothing shall bar the opening of Tender by the reason only that any bidder or its agent is not present. Bidder's representative should come with authorization duly signed by the authority of firm at the time of bid opening.
8. Bids must be valid for a period of 90 days counting from the date of bid opening and must be accompanied by a bid security (Bank Guarantee or Cash Deposited into Bank) amounting to amount mentioned above, which shall be valid for minimum 30 days beyond the bid validity period.
9. Bidder may submit Bank Guarantee for bid security as per given format of the document. If bidder wishes to submit the Cash Security, the cash should be deposited in Account Name: Bardibas Municipality Office, Bank Account No.:1006300751608022 at Agriculture Development Bank Ltd., Bardibas Branch and submit the original receipt of the deposited amount of cash along with the Sealed Bid.
10. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
11. Bidders are advised to visit site and assess the actual site conditions before submitting their bid. Bardibas Municipality Office shall not be responsible for any costs or expenses incurred by bidders in connection with preparation or submission of Bids.
12. Bardibas Municipality Office reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
13. Those owners whose firm or company was blacklisted earlier with the provisions of Public Procurement Act, 2007 and if they have commenced New Business in the name of new firm or company are not allowed to participate in the Bid Proceedings.
