- The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:00 hrs on 4<sup>th</sup> December 2021 at the **Office of the Municipal Executive, Bardibas**. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security, amounting to a minimum of NRs 98171.70, which shall be valid for 30 days beyond the validity period of the bid.
- If the Bidder wishes to submit the bid security in the form of cash, the cash should be deposited in Deposit Account **No.1006301149128067 at ADBL, Bardibas Branch** and submit the receipt of the deposited amount of cash along with the bid.
- If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
