The Government of Nepal [GoN] has allocated funds towards the cost of Construction of Bardibas Administrative Building and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Bardibas Administrative Building (Contract No: BM/NCB/077/078/WORKS/24). Bidding is open to all eligible bidders as per Section V of Bidding Document
2. Bardibas Municipality, Office of Municipal Executive invites electronic bids from eligible bidders for the construction of Construction of Bardibas Administrative Building under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 66489795.00
Minimum Work experience of similar size and nature: 1 Project with Nrs.106,383,671 .00

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Bardibas Municipality, Office of Municipal Executive, Bardibas, Bardibas, Mahottari, Province Two, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Bardibas Municipality, Office of Municipal Executive, Bardibas, Bardibas, Mahottari, Province Two, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 10000.0 NRs. till 03-06-2021 12:00 during office hours.

Bids received after this deadline will be rejected.
